That Small Claim Court was established in Niger State on the 10th day of October, 2018 vide a practice direction issued by the then Chief Judge Hon. Justice Maria Sanda Dzukogi in exercise of the powers conferred on him by section 274 of the Constitution of Federal Republic of Nigeria 1999 (as amended) and other relevant laws. Find attached copy of the said Practice Direction.

After the issuance of the Small Claims Practice Directions, 3 courts were designated to hear and determine matter within the jurisdiction of small claims court.

The objective is to provide easy access to an informal, inexpensive and speedy resolution of simple debt recovery disputes in the District Courts.
